

1 [Contract Amendment - InterVision Systems, LLC - Technology Marketplace - Not to Exceed
2 \$31,000,000]

3 **Resolution authorizing the Office of Contract Administration to enter into a First**
4 **Amendment for Technology Marketplace purchases between the City and County of**
5 **San Francisco and InterVision Systems, LLC, a Tier 1 contractor of the Technology**
6 **Marketplace 2.0, to increase the contract amount by \$11,000,000 for a total contract**
7 **amount not to exceed \$31,000,000 with no change to the three-year term to expire on**
8 **December 31, 2021, with two one-year options to extend, at the sole and absolute**
9 **discretion of the City.**

11 WHEREAS, Charter, Section 9.118(b), requires the Board of Supervisors to approve by
12 Resolution contracts estimated to cost the City \$10,000,000 or more; and

13 WHEREAS, The Office of Contract Administration wishes to procure information
14 technology products and services on an as-needed basis through the Technology
15 Marketplace; and

16 WHEREAS, This Agreement was competitively procured as required by Administrative
17 Code, Chapter 21.1, through Request for Proposals #99400 "Tiers 1 and 2 of the Technology
18 Marketplace 2.0" a Request for Proposal ("RFP") issued on June 20, 2018, in which City
19 selected Contractor as a qualified proposer pursuant to the RFP; and

20 WHEREAS, The Local Business Entity ("LBE") subcontracting participation
21 requirement for the contract is 15% for services, with the exception that the requirement will
22 be 10% for training services; and

23 WHEREAS, Contractor represents and warrants that it is qualified to perform the
24 services required by the City as set forth under the contract; and

1 WHEREAS, Contractor represents and warrants that it is qualified to perform the
2 services required by the City as set forth under the contract; and

3 WHEREAS, The City's Civil Service Commission approved the contract, File No.
4 44114-17/18 on July 10, 2018; and

5 WHEREAS, The Board of Supervisors approved the original contract on January 15,
6 2019, by Resolution No. 010-19; and

7 WHEREAS, The Office of Contract Administration proposes to amend this contract in
8 an amount not to exceed \$31,000,000 to meet City business needs; and

9 WHEREAS, Contract referenced above is substantially in the form attached and are on
10 file with the Clerk of the Board of Supervisors in File No. 200939, which is hereby declared to
11 be a part of this Resolution as if set forth fully herein; now, therefore, be it

12 RESOLVED, That the Board of Supervisors authorizes the Purchaser and Director of
13 the Office of Contract Administration to execute the First Amendment to the contract to
14 increase the contract amount by \$11,000,000 for a total contract amount not to exceed
15 \$31,000,000, with no change to the three-year term to expire on December 31, 2021, with two
16 one-year options to extend, at the sole and absolute discretion of the City ; and, be it

17 FURTHER RESOLVED, That within 30 days of the contract being fully executed by all
18 parties, the Purchaser and Director of the Office of Contract Administration shall provide the
19 final First Amendment to the Clerk of the Board for inclusion into the official file.
