8 **NO RIGHT TURN ON RED - ESTABLISH**

9 Dwight Street, eastbound, at San Bruno Avenue.

10 **NO RIGHT TURN ON RED - ESTABLISH**

11 Beach Blanket Babylon Boulevard (Green Street), eastbound, at Columbus  
12 Avenue.

13 **NO LEFT TURN AND NO U-TURN - RESCIND**

14 The Embarcadero, southbound, at Washington Street.

15 **NO U-TURN - RESCIND**

16 The Embarcadero, northbound, at Broadway.

17 **NO LEFT TURN - ESTABLISH**

18 Fulton Street, eastbound, at 43rd Avenue.

19 **NO RIGHT TURN ON RED FROM 7 AM TO 8 PM - ESTABLISH**

20 Geary Expressway and Laguna Street, all approaches.

21 **NO LEFT TURN, 7:00 AM TO 9:00 AM AND 4:00 TO 6:00 PM, EXCEPT SATURDAY  
AND SUNDAY - RESCIND**

22 **NO LEFT TURN - ESTABLISH**

23 Judah Street, both directions, at 14th Avenue.


