

1 [Sewer Emergency]

2 APPROVING THE EXPENDITURE OF FUNDS FOR THE EMERGENCY WORK TO REPAIR THE
3 STRUCTURALLY INADEQUATE SEWER ON OAKHURST LANE FROM WARREN DRIVE TO
4 CRESTMONT DRIVE.

5 WHEREAS, On February 10,1998, PUC Sewer Operations identified an emergency condition on
6 Oakhurst Lane between Crestmont Drive and Warren Drive; and,

7 WHEREAS, The existing sewer had failed, and immediate repairs were required in order to
8 protect the health, welfare, and property of the Citizens of San Francisco; and,

9 WHEREAS, DPW's Bureau of Engineering prepared Plans and Specifications for Contract No.
10 CW-168, "Oakhurst Lane Emergency Sewer Replacement" to line the existing 12-inch and 18-inch
11 diameter sewers located on Oakhurst Lane from Crestmont Drive to Warren Drive; and,

12 WHEREAS, The Contractor, J. F. Pacific Liners, Inc. began the emergency work on April 14,
13 1998 and completed it on July 3, 1998; and,

14 WHEREAS, The total estimated project cost is \$72,710, of which \$46,060 is for the construction
15 contract. Funds for this project are available from the Repair and Replacement (Fund 5C/CPF/R&R,
16 FAMIS Project No. CENRNR958, Job Order No. 1591N); and,

17 WHEREAS, The Public Utilities Commission, in accordance with the provisions of Section 6.30
18 of the Administrative Code of the City and County of San Francisco, declared the existence of an
19 emergency; now, therefore, be it

20 RESOLVED, That this Board of Supervisors hereby approves the expenditure of funds for the
21 emergency work to repair the structurally inadequate sewer on Oakhurst Lane between Crestmont Drive
22 and Warren Drive.


