

[EXTENDING SRVPP GRANT - STATE FUNDS]

AUTHORIZING THE DISTRICT ATTORNEY TO ACCEPT AND EXPEND GRANT FUNDS MADE AVAILABLE THROUGH THE CALIFORNIA OFFICE OF CRIMINAL JUSTICE PLANNING (OCJP) FOR THE CONTINUED OPERATION OF THE "STATUTORY RAPE VERTICAL PROSECUTION PROGRAM (SRVPP)" AND WAIVING INDIRECT COSTS DUE TO FUNDING CONSTRAINTS.

WHEREAS, the City and County of San Francisco has applied for, accepted, and received funding from the Governor's Office of Criminal Justice Planning for the operation of the Statutory Rape Vertical Prosecution Program; and

WHEREAS, the City and County of San Francisco desires to continue this project; and

WHEREAS, the Office of Criminal Justice Planning intends to continue funding the Statutory Rape Vertical Prosecution Program; now, therefore, be it

RESOLVED, that the District Attorney of the City and County of San Francisco is authorized, on its behalf, to apply for, accept and expend extensions and augmentations of the Statutory Rape Vertical Prosecution Program grant and waiving indirect costs due to funding constraints; and, be it


FURTHER RESOLVED, that the District Attorney is authorized to execute on behalf of the City and County of San Francisco the necessary Grant Award Agreements for this project, including any extensions, funding augmentations, or amendments thereof; and, be it

FURTHER RESOLVED, that any liability arising out of the performance of this Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and OCJP disclaim responsibility


1 for any such liability; and, be it

2 FURTHER RESOLVED, that grant funds received hereunder shall not be used to supplant
3 expenditures controlled by this body.




