23 Consumer Advocacy, for a two-year term ending April 27, 2006.

24 David Pilpel, succeeding Sue Cauthen, term expired, seat 7, must be experienced in  
25 Consumer Advocacy, for a two-year term ending April 27, 2006.

1           Garrett Jenkins succeeding himself, term expired, seat 8, must be a member of the  
2 public who has demonstrated interest in or has experience in the issues of citizen access and  
3 participation in local government, for a two-year term ending April 27, 2006.

5 public who has demonstrated interest in or has experience in the issues of citizen access and  
6 participation in local government, for a two-year term ending April 27, 2006.
