3 **Resolution authorizing the Department of the Environment to accept and expend a**  
4 **grant in the amount of \$11,002 from the California Integrated Waste Management Board**  
5 **for the purpose of increasing proper disposal of Household Hazardous Waste and**  
6 **supporting San Francisco's involvement in the California Product Stewardship Council.**

8 WHEREAS, The people of the State of California have enacted the California Oil  
9 Recycling Enhancement Act that provides funds to cities and counties for establishing and  
10 maintaining Household Hazardous Waste collection programs; and,

11 WHEREAS, the California Integrated Waste Management Board (CIWMB) has been  
12 delegated the responsibility for the administration of the program within the state, setting up  
13 necessary procedures governing application by cities and counties under the program; and,

14 WHEREAS, the City and County of San Francisco applied for and was awarded funds  
15 to promote its Household Hazardous Waste disposal programs and support its involvement in  
16 the California Product Stewardship Council; and,

17 WHEREAS, the California Product Stewardship Council promotes the production of  
18 less toxic materials, thus reducing the burden on local governments to provide management  
19 of toxic waste; and,

20 WHEREAS, the grant is a non-competitive grant that is available to the City and County  
21 of San Francisco from the California Integrated Waste Management Board; and,

22 WHEREAS, The grant budget does not include a provision for indirect costs; and,


23 WHEREAS, This grant does not require an ASO amendment; now, therefore, be it

25 the Environment to accept and expend the grant funds; and, be it


