10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. The City Attorney is hereby authorized to settle the action entitled City and
12 County of San Francisco v. Geary Courtyard Associates, et al., Case No. CGC 12-520504,
13 filed May 4, 2012, in San Francisco Superior Court; by the payment of \$95,000 to the City
14 from defendants for attorney's fees and costs. In addition, the authorized settlement provides
15 for entry of a permanent injunction that will maintain the affordable rents for low income
16 tenants residing at Geary Courtyard, 639 Geary Street in San Francisco. A copy of the
17 settlement agreement is contained in Board File No. 120929.

18 Section 2. The following parties were named in the lawsuits: plaintiff City and County
19 of San Francisco; defendants Geary Courtyard Associates, ERP Operating Limited
20 Partnership and Equity Residential.


