5 WHEREAS, Supervisor Tony Hall was elected in December 2000 to serve  
6 District 7 and all of the people of the City and County of San Francisco; and,

8 WHEREAS, Supervisor Hall has been a dedicated legislator serving with  
9 integrity, intelligence, and a willingness to work with all parties for the common good of

12 communities to create legislation addressing utility issues, specifically related to water supply,

20 agreement in the Edgehill Park area, retirement benefits payable to qualified survivors of

23 holding various hearings on City department performance audits, cable franchises, and

WHEREAS, Supervisor Hall has served on the San Francisco County Transportation Authority, Golden Gate Bridge Highway and Transportation District Board, San Francisco Local Agency Formation Commission, and numerous Board of Supervisors' Standing Committees, including, Chair of the Rules Committees, and member of the City Services, Transportation and Commerce and Neighborhood Services and Parks Committees; now, therefore, be it


