3 **Resolution urging Hyatt Fisherman's Wharf and HEI Le Meridien Hotel to allow its**  
4 **workers to choose, free from delay and intimidation, whether to have a union through a**  
5 **card-check neutrality agreement**

7 WHEREAS, In June 2008, workers of the two non-union hotels in our city, the Hyatt  
8 Fisherman's Wharf and the HEI Le Meridien, petitioned their respective general managers for  
9 a fair process, free from delay and intimidation, to choose whether to have a union through a  
10 check neutrality agreement; and

11 WHEREAS, After many worker pickets and community delegations, the management  
12 of both hotels have rejected a card-check process; and,

13 WHEREAS, On February 24, 2009, a large number of workers at these hotels publicly  
14 called for a consumer boycott of their own hotels and over 700 Local 2 members rallied and  
15 marched in support of a boycott of these two hotel; and,

16 WHEREAS, Other hotels across San Francisco area have already agreed to this same  
17 process including, most recently, the Four Seasons, St. Regis, and Intercontinental hotels.  
18 Additionally, Hyatt has already agreed to provide this same process to workers at all new  
19 hotels they open in San Francisco and San Mateo counties; and therefore be it

20 RESOLVED, That the Board of Supervisors of San Francisco urges the management  
21 of the Hyatt Fisherman's Wharf and HEI Le Meridien Hotels to honor the workers call for a  
22 card-check neutrality agreement; and therefore be it

23 FURTHER RESOLVED, That the City and County of San Francisco will honor and  
24 endorse the worker called boycotts of the Hyatt Fisherman's Wharf and HEI LE Meridien  
25 Hotels; and

1           FURTHER RESOLVED, All departments in line of San Francisco shall boycott the  
2 services provided by the Hyatt Fisherman's Wharf and HEI Le Meridien Hotels in for all  
3 business related to the functioning of the City and County government until such time as a  
4 card-check neutrality agreement will be honored by the hotels' respective management; and  
5 therefore be it

6           FURTHER RESOLVED, That the Clerk of Board of Supervisors shall send a  
7 letter and a copy of this resolution to the management of the Hyatt Fisherman Wharf and HEI  
8 Le Meridien Hotels affirming the above.
