3 **Ordinance authorizing settlement of the lawsuit filed by Kisha Henderson against the**

5 **in San Francisco Superior Court, Case No. CGC-24-612822; entitled Kisha Henderson v.**  
6 **City and County of San Francisco; the lawsuit involves an employment dispute.**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
10 authorizes the City Attorney to settle the action entitled Kisha Henderson v. City and County  
11 of San Francisco, San Francisco Superior Court, Case No. CGC-24-612822, by the payment  
12 of \$55,000. The lawsuit involves an employment dispute.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 March 11, 2024, and the following parties were named in the lawsuit: Plaintiff: Kisha  
16 Henderson; Defendant: City and County of San Francisco.
