3 **Resolution approving the settlement of the unlitigated claim filed by George S. Hall,**
4 **Inc. against the City and County of San Francisco for \$36,742.55; the claim was filed on**
5 **April 30, 2025; the claim involves a refund of gross receipts taxes for the 2020 to 2022**
6 **tax years; other material terms of the settlement are that George S. Hall, Inc. shall take**
7 **certain filing positions with respect to its gross receipts and other applicable taxes for**
8 **the 2023 and subsequent tax years.**

10 WHEREAS, George S. Hall, Inc. filed a claim on April 30, 2025, against the City and
11 County of San Francisco; and

12 WHEREAS, The claim involves a refund of gross receipts taxes; and

13 WHEREAS, The Office of the Treasurer and Tax Collector has recommended
14 settlement of the claim for refund of gross receipts taxes by payment of \$36,742.55, and
15 George S. Hall, Inc.'s agreement to take certain filing positions with respect to its gross
16 receipts and other applicable taxes for the 2023 and subsequent tax years; now, therefore, be
