11 Sascha Bittner, seat 11, succeeding Jessie Sandoval, resigned, must be a consumer
12 between the ages of 18 and 60, authorized to represent organizations that advocate for
13 younger people with disabilities, for the unexpired portion of a three-year term ending March
14 1, 2021;

15 Alexander Madrid, seat 9, succeeding Jim Blacksten, resigned, must be a member of the
16 Mayor's Disability Council, recommended to the Board by the Council, for the unexpired
17 portion of a three-year term ending March 1, 2022;

18 Daisy McArthur, seat 12, succeeding themselves, term expired, must be a member
19 representing the bargaining unit of the union that represents In-Home Supportive Services
20 independent providers, for a three-year term ending March 1, 2023;

21 Robin Wilson-Beattle, seat 13, succeeding Luis Calderon, term expired, must be a
22 consumer between the ages of 18 and 60, authorized to represent organizations that
23 advocate for younger people with disabilities, for a three-year term ending March 1, 2023.
