17 for new two-year term ending April 27, 2002;

18 Margaret Lacson, vacant seat, (Seat No. 4, must be appointed from names submitted by New  
19 California Media and be a journalist from a racial/ethnic-minority-owned news organization),  
20 for unexpired portion of two-year term ending April 27, 2001;

21 Tuesday Ray, succeeding herself, (Seat No. 5, must be appointed from names submitted by  
22 the League of Women Voters), for new two-year term ending April 27, 2002;

23 Hilda R. Bernstein, succeeding David Pilpel, (Seat No. 6, must be experienced in Consumer  
24 Advocacy), for new two-year term ending April 27, 2002;




