9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Scanvinski Jerome Hymes v. Milton
12 Bliss, et al., United States District Court – Northern District of California, Case
13 No. 16-cv-04288 JSC by the payment of \$35,000. The lawsuit involves alleged excessive
14 force and personal injuries by Sheriff's deputies.

15 Section 2. The above-named action was filed in United States District Court – Northern
16 District of California on July 28, 2016, and the following parties were named in the lawsuit:

18 Leonardini, Pierre A. Gray, Eugene A. Jones, Scott Neu, and Paul Timpano.





