9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Kathleen Carroll v. The City and  
12 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-15-544452 by  
13 the payment of \$162,500. The lawsuit involves alleged personal injury on a City sidewalk.


14 Section 2. The above-named action was filed in San Francisco Superior Court on




