WHEREAS, DPH was awarded a grant from PHFE in the amount of \$90,463 for a project entitled Prevention Umbrella for MSM in the Americas; for the period of April 10, 2009 through March 31, 2010; and,

WHEREAS, The purpose of this grant is to lead the overall scientific leadership and coordination of effort on the PUMA project; and,

WHEREAS, A request for retroactive approval is being sought because DPH did not receive the required grant documents until May 18, 2009, while the project's start date is April 10, 2009; and,

WHEREAS, As a condition of receiving the funds the PHFE requires DPH to enter into a Grant Agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. 090911, which is hereby declared to be a part of this resolution as if set forth fully within; and,

WHEREAS, The grant does not require an ASO amendment and reimburses DPH for one existing position: Chief Medical Director (Job Class 2237) at 0.30 FTE for the period from April 10, 2009 through March 31, 2010; and,

WHEREAS, The grant budget includes a provision for indirect costs in the amount of \$15,638; now, therefore, be it

RESOLVED, That DPH is hereby authorized to accept and expend retroactively a grant in the amount of \$90,463 from PHFE; and, be it

FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and, be it

FURTHER RESOLVED, That the Controller is directed to designate the positions funded under this agreement as a "G" or grant-funded position which would terminate when the agreement expires.

FURTHER RESOLVED, That the Director of Health is authorized to enter into the agreement on behalf of the City.
