WHEREAS, The United States Congress enacted the Transportation Equity Act for the 21<sup>st</sup> Century (TEA21) in June 1998, which made available approximately \$14.4 billion in federal funds to the California Department of Transportation (Caltrans); and,

WHEREAS, The Metropolitan Transportation Commission (MTC) will be reviewing project proposals from the nine-county Bay Area region for compliance with federal and state rules and regulations as promulgated by the Federal Highway Administration and Caltrans; and,

WHEREAS, MTC has advised that San Francisco's share of federal TEA21 funds for transportation enhancement projects totals \$2,700,000 and is available for eligible projects and programs through the end of federal FY 2002-03; and,

WHEREAS, Department of Parking and Traffic is requesting a TEA21 grant totaling \$296,389 to implement a "Share the Road" Bicycle Safety Campaign, and,

WHEREAS, The Department of Public is requesting a TEA21 grant totaling \$544,000 to implement neighborhood traffic-calming and beautification improvements near Cashmere and LaSalle, 25<sup>th</sup>, Dakota, and Texas, and La Playa and Great Highway; and,

WHEREAS, Under federal grant regulations, a local match totaling \$109,004 is required and indirect project costs are ineligible, and,

WHEREAS, The non-federal share of \$109,004 will be paid for with monies from departmental funds; now therefore be it
