Cask at Rincon would be the second location in San Francisco following our premium artisanal spirits, beer and wine store called "Cask", located at 17 Third Street at Market. The current Cask store can be viewed at CaskStore.com. The premium products to be offered at this second location would be the same as the original Cask. What sets Cask apart from typical Type 21 licensed stores is that we do not offer for sale any low grade alcoholic beverages, no mini airline bottles, and no alcoholic malt beverages. We also do not sell lottery tickets or cigarettes. We do offer cocktail tools, cocktail books, a vast selection of cocktail bitters and syrups, bottle engraving service, whiskey and wine clubs. Cask has been featured by Williams-Sonoma in their catalogs and online, and Cask has been included in articles ranging from Time Magazine for its' use of innovative mobile payment systems, to the San Francisco Chronicle which features it regularly in regards to premium spirits and all things cocktail related.

This second proposed Cask location would be inside the Rincon Center located at 121 Spear Street at Mission. It would not be visible from any street as the store location has no street-side frontage. This proposed Rincon Center location does not have any schools or religious facilities in the immediate neighborhood.

I can elaborate further on our community outreach later, although at this point I can report that we have made a presentation at a recent monthly meeting of the Alliance for a Better District 6 which encompasses the proposed location. At that meeting the board proposed, voted on, and agreed to submit a letter of support for our application for a license transfer to the Board of Supervisors, the ABC, and the Southern District Police Department.
