3 **Ordinance authorizing settlement of the lawsuit filed by Jose Chavarria against the City**  
4 **and County of San Francisco for \$3,000,000; the lawsuit was filed on September 30,**  
5 **2020, in San Francisco Superior Court, Case No. CGC-20-586880; entitled Jose**  
6 **Chavarria v. City and County of San Francisco, et al.; the lawsuit involves alleged**  
7 **personal injury arising out of police vehicle collision; other material terms of the**  
8 **settlement are City to waive \$33,607.51 offset for unpaid Zuckerberg San Francisco**  
9 **General Hospital bills.**

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
13 authorizes the City Attorney to settle the action entitled Jose Chavarria v. City and County of  
14 San Francisco, et al., San Francisco Superior Court, Case No. CGC-20-586880 by the  
15 payment of \$3,000,000 and City to waive \$33,607.51 offset for unpaid Zuckerberg San  
16 Francisco General Hospital bills. The lawsuit involves alleged personal injury arising out of  
17 police vehicle collision.

18 Section 2. The above-named action was filed in San Francisco Superior Court on  
19 September 30, 2020, and the following parties were named in the lawsuit: Jose Chavarria,  
20 Plaintiff; City and County of San Francisco and Andrew Lucas, Defendants.
