6 MOVED, That the Board of Supervisors of the City and County of San Francisco does hereby  
7 appoint the hereinafter designated person(s) to serve as member(s) of the Reentry Council,  
8 pursuant to the provisions of Administrative Code, Sections 5.1-1 through 5.1-6, for the terms  
9 specified:

10         Billey Hoang Le, seat 1, succeeding Jusef Nathan, term expired, must be a former  
11 inmate in the San Francisco County Jail, a California Department of Corrections and  
12 Rehabilitation facility, and/or a United States Bureau of Prison facility; and also must self-  
13 identify as a survivor of violence or crime, for the unexpired portion of a two-year term ending  
14 June 1, 2026;

15         Anthony Partee, seat 2, succeeding Joanna Hernandez, term expired, must be a  
16 former inmate in the San Francisco County Jail, a California Department of Corrections and  
17 Rehabilitation facility, and/or a United States Bureau of Prison facility; and also have expertise  
18 in providing services to individuals exiting the criminal justice system, for the unexpired portion  
19 of a two-year term ending June 1, 2026;

20         Joanna Pulido, seat 3, succeeding Linda Hurshman, term expired, must be a former  
21 inmate in the San Francisco County Jail, a California Department of Corrections and  
22 Rehabilitation facility, and/or a United States Bureau of Prison facility; and also must have  
23 been released from custody within three years of his/her appointment, for the unexpired  
24 portion of a two-year term ending June 1, 2026;

1           Lorenzo Juan Castaneda, seat 4, succeeding Jabari Jackson, term expired, must be a  
2 former inmate in the San Francisco County Jail, a California Department of Corrections and  
3 Rehabilitation facility, and/or a United States Bureau of Prison facility; and also must have  
4 served multiple terms of incarceration, for the unexpired portion of a two-year term ending  
5 June 1, 2026;

6           David Mauroff, seat 6, succeeding himself, term expired, must be a representative of  
7 the entity or agency primarily responsible for administering pretrial services involving  
8 alternatives to incarceration in San Francisco, for the unexpired portion of a two-year term  
9 ending June 1, 2026.


