17 term ending April 27, 2018.

18 Jane Weil, seat 3, succeeding Raymon Smith, term expired, must be a senior or
19 disabled resident of SOMA, for the unexpired portion of a two-year term ending April 27, 2019.

20 Kristian Romasanta, seat 4, succeeding themselves, term expired, must have affordable
21 housing expertise and familiarity with the SOMA neighborhood, for the unexpired portion of a
22 two-year term ending April 27, 2019.

1 Allan Manalo, seat 5, succeeding themselves, term expired, must represent a community-
2 based organization in SOMA, for the unexpired portion of a two-year term ending April 27,
3 2019.

4 John Elberling, seat 6, succeeding themselves, term expired, must be providing direct
5 services to SOMA families, for the unexpired portion of a two-year term ending April 27, 2018.

6 Thomas Temprano, seat 7, succeeding themselves, term expired, must have small
7 business expertise and a familiarity with the SOMA neighborhood, for the unexpired portion of
8 a two-year term ending April 27, 2018.


