2 AUTHORIZING THE DEPARTMENT OF PUBLIC WORKS TO APPLY, ACCEPT AND EXPEND  
3 A GRANT OF \$295,500 FROM THE STATE OF CALIFORNIA GENERAL FUND PROGRAM FOR  
4 IMPROVEMENTS TO HARVEY MILK PLAZA; WAIVING INDIRECT COSTS.

6 WHEREAS, The Legislature and the Governor of the State of California have approved grants  
7 for the project shown above; and,

8 WHEREAS, The State Department of Parks and Recreation has been delegated the  
9 responsibility for the administration of this grant project, setting up necessary procedures; and,

10 WHEREAS, Said procedures established by the State Department of Parks and Recreation  
11 require the applicant to certify by resolution the approval of applications before submission of said  
12 applications to the state; and,

13 WHEREAS, The applicant will enter into an agreement with the State of California for the  
14 subject project; and,

15 WHEREAS, Indirect costs are not allowed by the funder; now, therefore, be it

16 RESOLVED, That the Board of Supervisors hereby:

- 17 1. Approves the application, acceptance and expenditure of \$295,500 for improvements to Harvey  
18 Milk Plaza;
- 19 2. Certifies that the San Francisco Department of Public Works in in accordance with the general  
20 provisions of the agreement with the State of California;
- 21 3. Certifies that the City and County of San Francisco has sufficient funds to operate and maintain the  
22 projects funded under this program;
- 23 4. Certifies that the Department of Public Works has reviewed and understands the General Provision  
24 contained in the State/Local agreement shown in the procedural guide;

- 1 5. Appoints the Director or Acting Director as agent of the Department of Public Works to conduct all  
2 negotiations, execute and submit all documents, including, but not limited to, applications,  
3 agreements, amendments, payment requests and so on, which may be necessary for the  
4 completion of the aforementioned project; and  
5 6. Waives indirect costs as they are not allowed by the funder.






