3 **Resolution determining that the issuance of a Type 42 on-sale beer and wine**  
4 **public premises license to Timothy Lee for Liquid Gold, LLC, located at 1040**  
5 **Hyde Street (District 3), will serve the public convenience or necessity of the City**  
6 **and County of San Francisco in accordance with California Business and**  
7 **Professions Code, Section 23958.4, and recommending that the California**  
8 **Department of Alcoholic Beverage Control impose conditions on the issuance of**  
9 **the license.**

10  
11 WHEREAS, Timothy Lee is seeking the issuance of a Type 42 on-sale beer and  
12 wine license for Liquid Gold, LLC, located at 1040 Hyde Street; and,

13 WHEREAS, The Planning Department has verified that the area is properly  
14 zoned and recommends approval; and,

15 WHEREAS, The Police Department has filed twelve (12) protests with the  
16 Department of Alcoholic Beverage Control under California Business and Professions  
17 Code, Section 24013, and recommends that the Department of Alcoholic Beverage  
18 Control issue the liquor license with conditions; and

19 WHEREAS, The conditions recommended by the Police Department are the  
20 following: 1) Sales, service and consumption of alcoholic beverages shall be permitted  
21 from 12:00 p.m. until 12:00 a.m. (midnight) Sundays thru Thursdays and from 12:00  
22 p.m. until 2:00 a.m. Friday and Saturday (with the exception of the Holiday "New Years  
23 eve," then the establishment may be allowed to sell and service alcoholic beverages  
24 until 2:00 a.m.); 2) The sale of beer beverages for off-sale consumption is strictly  
25 prohibited; 3) No noise shall be audible beyond the area under the control of the

1 licensee as defined on the ABC-257; 4) The petitioner(s) shall be responsible for  
2 maintaining free of litter the area adjacent to the premises over which they have control;  
3 5) Loitering (defined as "to stand idly about; linger aimlessly without lawful business") is  
4 prohibited on any sidewalks or property adjacent to the licensed premises under the  
5 control of the licensee as depicted on the ABC-257; 6) Graffiti shall be removed from  
6 the premises and all parking lots under the control of the licensee within 72 hours of  
7 application. If the graffiti occurs on a Friday or weekend day, or on a holiday, the  
8 licensee shall remove the graffiti with 72 hours following the beginning of the next week  
9 day; 7) The interior lighting maintained therein shall be sufficient to make easily the  
10 discernable appearance and conduct of all persons and patrons in that portion of the  
11 premises where alcoholic beverages are sold, served, delivered or consumed. At no  
12 time shall the occupancy of the premise exceed the established lawful limit set by the  
13 San Francisco Fire Department; and 8) The exterior of the premises shall be equipped  
14 with lighting of sufficient power to illuminate and make easily discernible the appearance  
15 and conduct of all persons on or about the premises. Additionally, the position of such  
16 lighting shall not disturb the normal privacy and use of any neighboring residences;  
17 now, therefore, be it

Tim K. Lee of Liquid Gold, LLC, *dba:* Liquid Gold, has filed an application with the California Department of Alcoholic Beverage Control seeking a Type 42 (On-Sale Public Premise) license for 1040 Hyde Street. Liquid Gold plans on the creation of a beer and wine tasting room that will cater in the sales of small crafted beer and boutique type wines. They plan on making the wines available for sales to take home, but not the beer.

It should be noted that during the application process, notification date for the 500<sup>th</sup> mailer was on October 13, 2013. The Notice to the Public was posted on October 3, 2013.

For the purposes of this hearing, the California Department of Alcoholic Beverage Control (ABC) seeks a determination from the Board of Supervisors as to the approval or denial of this license.

Sales, service and consumption of alcoholic beverages shall be permitted from 12 pm until 12 am (midnight) Sundays thru Thursday and from 12 pm until 2:00 am Friday and Saturday (with the exception of the Holiday "New Years eve", then the establishment may be allowed to sell and service alcoholic beverages until 2 am).
2. The sale of beer beverages for off-sale consumption is strictly prohibited.
3. No noise shall be audible beyond the area under the control of the licensee as defined on the ABC-257.
4. The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control.
