10 WHEREAS, the Chief of Police of the City and County of San Francisco desires
11 to undertake a certain project designated "Community Crime Resistance Program"
12 (herein after referred to as "CCRP") funded from funds made available through the
13 Office of Criminal Justice Planning (herein after referred to as OCJP) for the reduction of
14 crime in the Sixth Street Corridor of the South of Market area; now therefore be it



17 RESOLVED, that the Chief of Police of the City and County of San Francisco is
18 authorized to execute on behalf of the Board of Supervisors of the City and County of
19 San Francisco the attached Grant Award Agreement including any extensions,
20 amendments thereof; and be it

22 FURTHER RESOLVED, that it is agreed that any liability arising out of the
23 performance of this Grant Award Agreement, including civil court actions for damages,
24 shall be the responsibility of the grantee and the authorizing agency. The State of
25 California and OCJP disclaim responsibility for and such liability; and be it

1 FURTHER RESOLVED, that the board of Supervisors hereby waive indirect costs;
2 and be it

4 FURTHER RESOLVED, that grant funds received hereunder shall not be used to
5 supplant expenditures controlled by this body; and be it

7 FURTHER RESOLVED, that the Chief of Police of the City and County of San
8 Francisco is authorized to accept and expend funds in the amount of
9 ONE HUNDRED TWO THOUSAND-FIVE HUNDRED FIFTY SIX DOLLARS
10 (\$102,556.00) made available through the Office of Criminal Justice Planning for the
11 project known as "CCRP", and agreeing to provide a match of ELEVEN THOUSAND
12 THREE HUNDRED NINETY FIVE (\$11,395.00) DOLLARS.




