4 **RISE (Recovery with Inclusive and Successful Enrichment) Working Group to advise**  
5 **the Board of Supervisors, the Mayor, and the San Francisco Unified School District**

17 Be it ordained by the People of the City and County of San Francisco:

18 Section 1. Chapter 5 of the Administrative Code is hereby amended by adding Article  
19 XLVIII, consisting of Sections 5.48-1 through 5.48-7, to read as follows:

20 **ARTICLE XLVIII:**

21 **STUDENTS AND FAMILIES RISE (RECOVERY WITH INCLUSIVE AND SUCCESSFUL**  
22 **ENRICHMENT) WORKING GROUP**

23 **SEC. 5.48-1. CREATION OF WORKING GROUP.**

24 *There is hereby established the Students and Families RISE (Recovery with Inclusive and*  
25 *Successful Enrichment) Working Group (the “Working Group”) of the City and County of San*  
*Francisco.*

1           **SEC. 5.48-2. PURPOSE AND GOALS.**

2           (a) The purpose of the Working Group is to advise the Board of Supervisors, the Mayor, and  
3 the San Francisco Unified School District (“SFUSD”) on the coordination and expansion of academic  
4 and literacy supports, enrichment services, post-secondary education enrollment, summer learning and  
5 transition supports, justice services, mentorship, out of school time programming, youth workforce  
6 development, and family empowerment programs, to assist San Francisco youth whose academic  
7 achievement and personal development have been negatively impacted by school closures and distance  
8 learning during the COVID-19 public health emergency.

9           (b) The primary goals of the Working Group shall be to increase student proficiency so  
10 that students are performing at grade level, increase SFUSD enrollment to mitigate the  
11 negative impacts of family flight during distance learning, and create and expand full scale, in-  
12 school enrichment programs, including programs in arts, music, sports, and libraries, which  
13 fully nurture the minds and development of our students.

14  
15           **SEC. 5.48-3. MEMBERSHIP.**

16           (a) The Working Group shall consist of ~~40~~ 11 voting members.

17           (b) Seats 1 through ~~7~~ 8 shall be appointed by the Board of Supervisors as follows:

18           (1) Seat 1 shall be held by a member of the United Educators of San Francisco. In  
19 making the appointment, the Board of Supervisors shall consider any recommendations for the seat  
20 made by the United Educators of San Francisco.

21           (2) Seat 2 shall be held by a member of the Service Employees International  
22 Union Local 1021. In making the appointment, the Board of Supervisors shall consider any  
23 recommendations for the seat made by the Service Employees International Union Local  
24 1021.

1           (23) Seat 23 shall be held by a parent or guardian of a youth enrolled, at the time of  
2 appointment, in an SFUSD school, at any grade level from pre-kindergarten through 12th grade.

3           (34) Seat 34 shall be held by a person who works as, or has substantial experience  
4 working as, a service provider delivering services to youth and families in San Francisco, preferably in  
5 San Francisco low-income communities.

6           (45) Seat 45 shall be held by a person with expertise or substantial experience in the  
7 field of public health, preferably a person specializing in pediatric public health or child development.

8           (56) Seat 56 shall be held by a person with expertise or substantial experience in the  
9 field of education research, preferably focused on student achievement and retention.

10           (67) Seat 67 shall be held by a person representing a philanthropic organization,  
11 foundation, or network.

12           (78) Seat 78 shall be held by a person 19 years old or younger at the time of  
13 appointment for the term who is either enrolled in, or has recently graduated from a SFUSD school.

14           (c) Seat 89 shall be held by an employee of the Department of Children, Youth, and their  
15 Families (“DCYF”), appointed by the Mayor.

16           (d) Seat 910 shall be held by a Commissioner serving on, and designated by, the SFUSD  
17 Board of Education. If at any time the SFUSD Board of Education declines to designate a  
18 Commissioner to participate, and seat 910 is vacant for 60 days or longer, the Board of Supervisors  
19 may appoint a member of the public to fill the seat until such time as the SFUSD Board of Education  
20 designates a Commissioner.

21           (e) Seat 4011 shall be held by the SFUSD Superintendent of Schools (“the Superintendent”)  
22 or the Superintendent’s designee. If at any time the Superintendent declines to participate, and also  
23 declines to name a designee, and leaves seat 4011 vacant for 60 days or longer, the Board of  
24 Supervisors may appoint a member of the public to fill the seat until such time as the Superintendent  
25 elects to participate or name a designee.

1           **SEC. 5.48-4. ORGANIZATION AND TERMS OF OFFICE.**

2           (a) Members of the Working Group holding seats 1 through 89 shall serve at the pleasure of  
3 their appointing authority and may be removed by their appointing authority at any time. Each  
4 member of the Working Group holding seats 1 through 89 shall serve a one-year term, unless removed  
5 by their appointing authority.

6           (b) Service in the Working Group shall be voluntary, and members shall not be  
7 compensated for their time, except that the person appointed to Seat 89 shall receive their City salary  
8 for time spent serving on the Working Group, which shall be considered part of their responsibilities as  
9 a City official or employee.

10          (c) Any member who misses three regular meetings of the Working Group within a six-  
11 month period without the express approval of the Working Group at or before each missed meeting  
12 shall be deemed to have resigned from the Working Group 10 days after the third unapproved absence.  
13 The Working Group shall inform the Board of Supervisors of any such resignation.

14          (d) DCYF shall provide administrative support for the Working Group.

15          (e) At the request of the Working Group, and subject to the fiscal, budgetary, and civil  
16 service provisions of the Charter and all applicable rules regarding competitive selection, DCYF may  
17 retain consultants with appropriate expertise to assist the Working Group in its development of the San  
18 Francisco Students and Families RISE (Recovery with Inclusive and Successful Enrichment) Plan.

19           **SEC. 5.48-5. MEETINGS AND PROCEDURES.**

20          (a) The appointing authorities shall make initial appointments to the Working Group within  
21 30 days of the effective date of this Article.

22          (b) The Working Group shall hold its inaugural meeting not more than 45 days after the  
23 effective date of the ordinance in Board File No. 210032 enacting this Article XLVIII. There shall be at  
24 least ten days' public notice of the inaugural meeting. Following the inaugural meeting, the Working  
25 Group shall hold a regular meeting not less than once each month.

1           (c) The Working Group shall elect a chair and such other officers as it deems appropriate,  
2 and may establish bylaws and rules for its organization and procedures.

3           **SEC. 5.48-6. POWERS AND DUTIES.**

4           (a) The Working Group shall advise the Board of Supervisors, Mayor, and SFUSD in the  
5 development, adoption, and implementation of a San Francisco Students and Families RISE (Recovery  
6 with Inclusive and Successful Enrichment) Plan (“Plan”) to coordinate services provided to youth and  
7 families by City departments, SFUSD, and community partners, and to maximize support for youth in  
8 San Francisco whose academic experience has been hindered by school closures, distance learning,  
9 and the COVID-19 pandemic. In developing the Plan, the Working Group shall consider the following:

10           (1) Data on student performance including attendance, course completion,  
11 standardized tests scores, and student surveys, available across various disaggregated demographic  
12 categories.

13           (2) Data on the number of youths who left the public school system during the  
14 COVID-19 pandemic.

15           (3) Best practices and academic interventions in and outside of the classroom for  
16 addressing student learning loss, academic setbacks, and social and emotional challenges stemming  
17 from school closures and trauma associated with the COVID-19 health crisis.

18           (4) Accessibility of enrichment and retention services for youth and families.

19           (5) Equitable prioritization in the delivery of services to the youth and families with  
20 the greatest needs and who have been disproportionately impacted by school closures and the COVID-  
21 19 pandemic.

22           (6) Input or recommendations from San Francisco youth leaders including, but not  
23 limited to, representatives from the San Francisco Youth Commission and the SFUSD Student Advisory  
24 Council.

1           **(b) The Plan shall include an equity analysis of services and resources for youth and**  
2 **families and a five-year budget estimate of additional revenue needed by SFUSD to remediate learning**  
3 **loss due to the COVID-19 pandemic and expand enrichment and wraparound services consistent with a**  
4 **community schools' model.**

5           **(c) By August 1, 2021, the Working Group shall submit the Plan to the Board of**  
6 **Supervisors, the Mayor, and SFUSD. The Plan shall include a timeline for implementing all**  
7 **components and recommendations within the plan by the end of the 2021-2022 academic**  
8 **year. The Plan shall be accompanied by a proposed resolution for the Board of Supervisors to accept**  
9 **the Plan, and the Board may act by resolution to accept or reject the Plan.**

10           **SEC. 5.48-7. SUNSET.**

11           **Unless the Board of Supervisors by ordinance extends the term of the Working Group, this**  
12 **Article XLVIII shall expire by operation of law, and the Working Group shall terminate, one year after**  
13 **the effective date of the ordinance in Board File No. 210032 enacting this Article. In that event, after**  
14 **the sunset date, the City Attorney shall cause this Article XLVIII to be removed from the Administrative**  
15 **Code.**

16  
17           Section 2. Effective Date. This ordinance shall become effective 30 days after  
18 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
19 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
20 of Supervisors overrides the Mayor's veto of the ordinance.

**LEGISLATIVE DIGEST**

(Revised 02/22/21)

[Administrative Code - Establishing the Students and Families RISE (Recovery with Inclusive and Successful Enrichment) Working Group]

**Ordinance amending the Administrative Code to establish the Students and Families RISE (Recovery with Inclusive and Successful Enrichment) Working Group to advise the Board of Supervisors, the Mayor, and the San Francisco Unified School District regarding the development, adoption, and implementation of a plan to coordinate enrichment and retention services provided by City departments, the School District, and community partners to youth and families adversely affected by COVID-19 school closures and distance learning programs.**

Existing Law

There is currently no City advisory body dedicated to planning or coordinating advice regarding enrichment and retention services provided the City and San Francisco School District (“SFUSD”) to youth and families adversely affected by the COVID 19 school closures.

Amendments to Current Law

The proposed ordinance would create an 11-member advisory body called Students and Families RISE (Recovery with Inclusive and Successful Enrichment) Working Group (“Working Group”) to advise the City and SFUSD regarding the development, adoption, and implementation of a plan to coordinate enrichment and retention services provided by City departments, the School District, and community partners to youth and families adversely affected by COVID-19 school closures and distance learning programs. Eight members would be appointed by the Board of Supervisors. The Mayor would appoint an employee of the Department of Children, Youth, and their Families (“DCYF”) to one seat. One seat would be held by a Commissioner serving on, and designated by, the SFUSD Board of Education. One seat would be held by the SFUSD Superintendent of Schools (“the Superintendent”) or the Superintendent’s designee. If at any time either the School Board or the Superintendent declined to participate, and either seat remained vacant for 60 days or longer, the Board of Supervisors would fill the seat until such time as the Superintendent or School Board elected to participate or name a designee.

By August 1, 2021, the Working Group would prepare and submit to the Board, the Mayor, and SFUSD a San Francisco Students and Families RISE (Recovery with Inclusive and Successful Enrichment) Plan to coordinate services provided to youth and families by City departments, SFUSD, and community partners, and to maximize support for youth in San Francisco whose academic experience has been hindered by school closures, distance

learning, and the COVID-19 pandemic. The Plan would include a timeline for implementing all components and recommendations within the plan by the end of the 2021-2022 academic year. The Working Group would terminate in one year, unless extended by ordinance adopted by the Board.

### Background

The proposed ordinance includes amendments adopted by the Rules Committee on February 22, 2021.

- Public schools in SF closed for in-person learning since March 2020
- SFUSD serves ~ 52,000 students
- “Fall 2020 Attendance and Academic Performance during COVID-19 Pandemic”  
— SFUSD Jan 2021 report indicates inequities



- **Learning loss increased under COVID-19. In SF, the biggest disparities are among Black, Latino and Pacific Islander students.**
- **Gap has widened for low-income students; English language learners, special education students, and unhoused students.**
- **Overall, disparities exist in performance in reading and math. Students are falling further behind in math than reading.**
- **Black, Pacific Islander, and unhoused students showed sharpest declines in attendance despite SFUSD reporting flat attendance rates over a 3-year period.**
- **910 students attended class less than 40% of the time**



**This is not the whole story.**

## Need More Information

---

“Learning loss” in reading and math is only **one indicator** determine student achievement.

## Student Ability is Unclear

---

Projected student growth *versus* actual outcomes doesn't always match to ability.

## It's all Relative

---

Shouldn't be used to infer absolute growth, just a relative metric. Compares students, not actual success.

## Disparities in the Data

---

Predictions can downplay systemic and persistent disparities. Vulnerable kids are likely missing.

- Statistical significance vs. social significance
- Given 2020/2021 SY will this create a new baseline?

- Remote learning's impact on depression and student mental health

- Food insecurity

Board of Supervisors Rules of Order 2.21 establishes certain criteria that shall be included in legislation creating and establishing, or reauthorizing, new bodies (boards/commissions/task forces/advisory bodies.) This Rule also requires the Clerk of the Board to advise the Board if this criteria has been met. This memo is provided to fulfill these requirements.

File No. 210032      Administrative Code - Establishing the Students and Families RISE

- Does a current body address the same or similar subject matter?

*No, there are no other bodies that address similar subjects.*

- Language requiring the body to meet at least once every four months

*Page 4, Lines 17-18, entitled "SEC. 5.48-5. MEETINGS AND PROCEDURES" states "Following the inaugural meeting, the working Group shall hold a regular meeting not less than once each month."*



- Language indicating members serve at the pleasure of the appointing authority

*Page 3, Lines 18-22, entitled "SEC. 5.48-4. ORGANIZATION AND TERMS OF OFFICE" states "Members of the Working Group holding seats 1 through 8 shall serve at the pleasure of their appointing authority and may be removed by their appointing authority at any time. Each member of the Working Group holding seats 1 through 8 shall serve a one-year term, unless removed by their appointing authority."*

- Language establishing attendance requirements

*Page 4, Lines 3-7, entitled "SEC. 5.48-4. ORGANIZATION AND TERMS OF OFFICE" states "Any member who misses three regular meetings of the Working Group within a six-month period without the express approval of the Working Group at or before each missed meeting shall be deemed to have resigned from the Working Group 10 days after the third unapproved absence. The Working Group shall inform the Board of Supervisors of any such resignation."*

- Number of seats and qualifications

*There are a total of 11 voting members: 8 appointed by the Board of Supervisors (seats 1-7), 1 appointed by the Mayor who shall be an employee of the DCYF, 1 shall be a Commissioner of the SFUSD Board of Education, and the SFUSD Superintendent of Schools or their designee.*

*Seat 1 shall be held by a member of the United Educators of San Francisco. In making the appointment, the Board of Supervisors shall consider any recommendations for the seat made by the United Educators of San Francisco.*

*Seat 2 shall be held by a member of the Service Employees International Union Local 1021. In making the appointment, the Board of Supervisors shall consider any recommendations for the seat made by the Service Employees International Union Local 1021.*

*Seat 3 shall be held by a parent or guardian of a youth enrolled, at the time of appointment, in an SFUSD school, at any grade level from pre-kindergarten through 12th grade.*

*Seat 4 shall be held by a person who works as, or has substantial experience working as, a service provider delivering services to youth and families in San Francisco, preferably in San Francisco low-income communities.*



*Seat 5 shall be held by a person with expertise or substantial experience in the field of public health, preferably a person specializing in pediatric public health or child development.*

*Seat 6 shall be held by a person with expertise or substantial experience in the field of education research, preferably focused on student achievement and retention.*

*Seat 7 shall be held by a person representing a philanthropic organization, foundation, or network.*

*Seat 8 shall be held by a person 19 years old or younger at the time of appointment for the term who is either enrolled in, or has recently graduated from a SFUSD school.*

*Seat 9 shall be held by an employee of the Department of Children, Youth, and their Families (“DCYF”), appointed by the Mayor.*

*Seat 10 shall be held by a Commissioner serving on, and designated by, the SFUSD Board of Education. If at any time the SFUSD Board of Education declines to designate a Commissioner to participate, and seat 9 is vacant for 60 days or longer, the Board of Supervisors may appoint a member of the public to fill the seat until such time as the SFUSD Board of Education designates a Commissioner.*

*Seat 11 shall be held by the SFUSD Superintendent of Schools (“the Superintendent”) or the Superintendent’s designee. If at any time the Superintendent declines to participate, and also declines to name a designee, and leaves seat 10 vacant for 60 days or longer, the Board of Supervisors may appoint a member of the public to fill the seat until such time as the Superintendent elects to participate or name a designee.*

- Term limits (i.e., commencement date? staggered terms?)

*Page 3, Lines 18-22, entitled “SEC. 5.48-4. ORGANIZATION AND TERMS OF OFFICE” states “Members of the Working Group holding seats 1 through 8 shall serve at the pleasure of their appointing authority and may be removed by their appointing authority at any time. Each member of the Working Group holding seats 1 through 8 shall serve a one-year term, unless removed by their appointing authority.”*

- Administering department

*DCYF shall provide administrative support for the Working Group.*



- Reporting requirements

*The Working Group shall advise the Board of Supervisors, Mayor, and SFUSD in the development, adoption, and implementation of a San Francisco Students and Families RISE (Recovery with Inclusive and Successful Enrichment) Plan ("Plan") to coordinate services provided to youth and families by City departments, SFUSD, and community partners, and to maximize support for youth in San Francisco whose academic experience has been hindered by school closures, distance learning, and the COVID-19 pandemic.*

*The Plan shall include an equity analysis of services and resources for youth and families and a five-year budget estimate of additional revenue needed by SFUSD to remediate learning loss due to the COVID-19 pandemic and expand enrichment and wraparound services consistent with a community schools' model.*

*By August 1, 2021, the Working Group shall submit the Plan to the Board of Supervisors, the Mayor, and SFUSD. The Plan shall be accompanied by a proposed resolution for the Board of Supervisors to accept the Plan, and the Board may act by resolution to accept or reject the Plan.*

- Sunset date

*Unless the Board of Supervisors by ordinance extends the term the Working Group shall terminate one year after the effective date of the ordinance.*
