15 Section 1. The Board of Supervisors approves the Fourth Amendment to Advertising  
16 Transit Shelter Agreement by and between the City and County of San Francisco and CBS  
17 Outdoor, Inc., approved by Municipal Transportation Agency Board of Directors Resolution  
18 No. 06-094, adopted July 25, 2006, and Port Commission Resolution No. 06-65, adopted  
19 September 26, 2006, a copy of which Amendment is contained in Board of Supervisors' file  
20 number 061370, except to the extent the contract extends the agreement  
between the parties six months.


