9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Article 12 of the San Francisco Park Code is hereby amended by adding
 11 Section 12.11, to read as follows:

12 **SEC. 12.11 Marina Fees.**

13 The following fees shall be charged for goods and services provided to berthholders and
 14 transient boaters at the San Francisco Marina Small Craft Harbor:

16 Pumpout (boat taking on water first time)	\$50.00
17 Pumpout (boat taking on water after first time)	\$100.00
18 Towing	\$50.00
19 Hazardous Waste removal	\$50.00
20 Installation of Harbor Line	\$25.00

23 Harbor Line	\$25.00


