3 **Resolution fixing the highest general prevailing rate of wages, including wages for**
4 **overtime and holiday work, for various crafts and kinds of labor as paid for similar**
5 **work in private employment in the City and County of San Francisco at the rates**
6 **certified to the Board by the Civil Service Commission on December 4, 2000, as**
7 **modified by the Garage and Parking Lot Attendant Agreement (December 1, 2000 –**
8 **November 30, 2003).**

10 WHEREAS, The Board of Supervisors, in accordance with Administrative Code section
11 6.22, is required to fix the highest general prevailing rate of wages, including wages paid for
12 holiday and overtime work, for various crafts and kinds of labor as paid for similar work in
13 private employment in the City and County of San Francisco; and

14 WHEREAS, The Civil Service Commission at its meeting of December 4, 2000,
15 certified and forwarded to the Board of Supervisors data as to the highest general prevailing
16 rate of wages, including wages paid for holiday and overtime work, for various crafts and
17 kinds of labor as paid for similar work in private employment in the City and County of San
18 Francisco; now, therefore, be it

19 RESOLVED, That the Board of Supervisors hereby adopts the data certified by the
20 Civil Service Commission at its meeting of December 4, 2000, modified by the Garage and
21 Parking Lot Attendant Agreement (Teamsters Automotive Union, Local 665) for the period
22 December 1, 2000 through November 30, 2003; and, be it

23 FURTHER RESOLVED, That the Board of Supervisors hereby fixes the highest
24 general prevailing rate of wages, including wages paid for holiday and overtime work, for

1 various crafts and kinds of labor as paid for similar work in private employment in the City and
2 County of San Francisco. A copy of the prevailing wages so fixed is on file with the Clerk of
3 the Board of Supervisors in File No. 010546, which is hereby declared to be a part of this
4 resolution as if set forth fully herein.




