3 **Resolution establishing temporary occupancy of a portion of the commercial vehicle**
4 **parking meters on the north side of Post Street between Kearny and Montgomery from**
5 **8:30am to 5:00pm on every Thursday beginning July 14, 2005 through November 30,**
6 **2005 2006.**

7 WHEREAS, Farmers' markets provide the opportunity for consumers to purchase fresh
8 organic fruits and vegetables; and

9 WHEREAS, Farmers' markets create opportunities for market goers to gather together
10 and help enhance a sense of community within a neighborhood; and

11 WHEREAS, Increasing walking traffic in neighborhood commercial districts tends to
12 enhance the overall economic vitality of the district; and

13 WHEREAS, Food sold and purchased at farmers' markets travels a shorter distance
14 from field to table than most food in the grocery store thus saving fuel and helping to protect
15 the environment; and

16 WHEREAS, The Sustainability Plan for the City and County of San Francisco, adopted
17 by the Board of Supervisors in 1997, lists access to nutritious, affordable, and safe food as a
18 principle goal; and

19 WHEREAS, The Sustainability Plan identifies creating farmers' markets in every
20 neighborhood in San Francisco as a long-term objective; and,

21 WHEREAS, The San Francisco Certified Farmers' Market at the Crocker Galleria
22 would provide residents with access to fruits and vegetables that will help Financial District
23 market goers meet their nutritional needs; and,

1 WHEREAS, ISCOTT approval of the temporary occupancy of commercial vehicle
2 parking meters will be filed with the Clerk of the Board of Supervisors in File No. 051387,
3 which is hereby declared to be a part of this resolution as set forth fully herein; and,

4 WHEREAS, Section 202.E(3) of the San Francisco Traffic Code sets forth a fee for
5 issuance of permits for exclusive temporary use of parking meters of \$4 per parking
6 meter zone per day, including Sundays and Holidays, a fee which shall be deposited in
7 the Off-Street Parking Fund at the time the permit is issued; and,

8 WHEREAS, The Board of Supervisors is the appropriate policy body to approve an
9 extended temporary occupancy permit; now, therefore, be it

10 RESOLVED, That in accordance with the provisions of the California Vehicle code and
11 the San Francisco Traffic Code, the following regulation governing the movement of vehicles
12 is hereby enacted as designated below.

16 614-00340) 8:30 A.M. to 5:00 P.M., Every Thursday Beginning July 14, 2005 through
17 November 34 30, 2005 2006 on the north side of Post Street between Kearny and
18 Montgomery Streets for a Certified Farmers' Market.


