

1 [Fee Waiver for Temporary Occupancy Permit of Hunger Strikers]

3 **Resolution commending the 23 individuals who participated in the week-long Hunger**
4 **Strike against the "Border Protection, Anti-Terrorism, and Illegal Immigration Control**
5 **Act," also known as HR 4437, for their commitment to protect the San Francisco's City**
6 **of Refuge status, and urging the Department of Public Works to waive their Temporary**
7 **Occupancy permit fees for the week of March 21st, 2006.**

8 WHEREAS, On January 24, 2006, the Board of Supervisors approved Resolution 33-
9 06 Affirming the San Francisco's City of Refuge Ordinance and condemning the "Border
10 Protection, Anti-Terrorism, and Illegal Immigration Control Act the San Francisco Board of
11 Supervisors condemns the passage of HR 4437 in the US House of Representatives; and,

12 WHEREAS, Resolution 33-06 also urges the U.S. Senate to defeat HR4437 and all its
13 provisions, and urged Senators Boxer and Feinstein to vote NO on the measure; and,

14 WHEREAS, During the week of March 21st, 23 Bay Area Residents, participated in a
15 Hunger Strike in front of the Federal Building in order to bring public attention to the
16 devastating impact of this bill, and to urge Federal Representatives to defeat similar measures
17 in the House of Representatives; and ,

18 WHEREAS, The Hunger Strikers needed to take in lots of fluids and therefore had to
19 maintain a temporary restroom in close proximity, which required a Temporary Occupancy
20 Permit from the Department of Public Works for the amount of \$362.29; therefore, be it

22 RESOLVED, That the Board of Supervisors commend the 23 Hunger Strikers for their
23 courage, sacrifice, and commitment to immigrant rights and social justice; and

24 RESOLVED, The Board of Supervisors urge the Department of Public Works to waive
25 the fee for the Temporary Occupancy permit issued to the Hungry Strikers.




