15 the issuance of a Type 20 off-sale beer and wine alcoholic beverage control license with conditions to Xu Ji Lian for  
16 23<sup>rd</sup> Irving Supermarket, located at 2201 Irving Street will serve the convenience of the people of the City and  
17 County of San Francisco.

18 Conditions: 1) No sale of fortified wine. 2) No sale of malt liquor in single cans.


