| 15 | WHEREAS, DPH entered into an agreement with Tryfacta, Inc. on May 22, 2021, to |
| 16 | provide these services for two years and seven months, with the term of June 1, 2021, |
| 17 | through December 31, 2023, for an amount not to exceed \$5,000,000; and |
| 18 | WHEREAS, DPH amended the agreement between DPH and Tryfacta, Inc. on |
| 19 | January 13, 2023, to increase the amount by \$4,000,000, for an amount not to exceed |
| 20 | \$9,000,000; and |
| 21 | WHEREAS, DPH amended the agreement between DPH and Tryfacta, Inc. on |
| 22 | August 18, 2023, to extend the term by one year from June 1, 2021, through December 31, |
| 23 | 2024, and increase the amount by \$900,000, for an amount not to exceed \$9,900,000; and |
