10 MOVED, That the Board of Supervisors of the City and County of San Francisco does  
11 hereby amend Rule 4.29 of the Rules of Order of the Board of Supervisors to read as follows:

12 4.29. Special Times of Business. The Clerk of the Board shall schedule public  
13 hearings on appeals for ~~3:00~~ 4:00 p.m. If more than one public hearing on appeal is scheduled for  
14 in conjunction with is  
a Board meeting, the Clerk of the Board and the President are urged to determine the order in which  
15 the appeals will be scheduled, and they may schedule second and later appeals at specified times later  
16 than 4 p.m. If a public hearing appeal is scheduled later than 4 p.m. the calendar shall contain notice  
17 that the appeal shall not be heard prior to the scheduled time stated on the calendar, and that the  
18 appeal may not be called until the Board's consideration of appeals scheduled earlier on the calendar  
19 is completed. The Clerk of the Board shall schedule consideration of ballot arguments and  
20 other election related matters when action is needed by the following day for 2:00 p.m. The  
21 recognition of visiting dignitaries shall occur at 3:30 p.m., and the recognition of  
22 commendations shall occur at 3:45 p.m. These recognitions of commendations should  
23 require no more than five minutes per recognition. No other fixed time for consideration of an  
24 agenda item shall be placed on the agenda except as directed by the President, or by  
25 affirmative vote of six Supervisors.
