

1 [Assembly Bill 106, Refundable Earned Income Tax Credit.]

3 **Resolution supporting Assembly Bill 106, the Refundable Earned Income Tax Credit**  
4 **and urging the local delegation to the California State Assembly to support the bill.**

6 WHEREAS, Assembly Bill 106 creates a State Earned Income Tax Credit (EITC),  
7 which utilizes the tax system to target assistance to low income working households; and,

8 WHEREAS, AB 106 is patterned after the federal EITC, which provides a refundable  
9 tax credit for low income families; and,

10 WHEREAS, A state EITC equivalent to 15 percent of the federal EITC would provide a  
11 credit of up to \$583 per family with two or more children and \$353 per family with one child;  
12 and,

13 WHEREAS, Economic trends have made it harder for many families to rise out of  
14 poverty despite the presence of one or even two working parents and a state EITC that  
15 complements the federal EITC is a powerful tool for lifting working families out of poverty; and

16 WHEREAS, The eleven states that have already enacted a state EITC have been  
17 successful in reducing child poverty, supporting welfare-to-work efforts and cutting taxes for  
18 families struggling to make ends meet; and,

19 WHEREAS, AB 106 is supported by the California Budget Project, the Western Center  
20 on Law and Poverty, the California Tax Reform Association, the Educational Fund, and the  
21 Children's Advocacy Institute, among others; now, therefore, be it

22 RESOLVED, That the Board of Supervisors for the City and County of San Francisco  
23 hereby supports Assembly Bill 106; and, be it




