4 **Cuddihy against the City and County of San Francisco for \$43,000; the lawsuit was filed**  
5 **on July 1, 2016, in San Francisco Superior Court, Case No. CGC-16-552818; entitled**  
6 **Peter Cuddihy and Joan Cuddihy v. City and County of San Francisco; the lawsuit**  
7 **involves widespread flooding to the area surrounding the intersection of 15th Avenue**  
8 **and Wawona Street due to heavy rains on December 3, 2014.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
12 authorizes the City Attorney to settle the action entitled Peter Cuddihy and Joan Cuddihy, San  
13 Francisco Superior Court, Case No. CGC-16-552818 by the payment of \$43,000. The lawsuit  
14 involves widespread flooding to the area surrounding the intersection of 15th Avenue and  
15 Wawona Street due to heavy rains on December 3, 2014.

16 Section 2. The above-named action was filed in San Francisco Superior Court on  
17 July 1, 2016, and the following parties were named in the lawsuit: Plaintiffs: Peter Cuddihy  
18 and Joan Cuddihy, Defendant: City and County of San Francisco.




