**Comments (If you are not in compliance with Reflectiveness/Representation, please provide a detailed yet succinct narrative on how you plan to comply; in addition, please list the membership categories that are currently vacant):** The Membership Committee is currently actively recruiting non-aligned consumers, as well as African American, Latino, and Native American council members. Typical mechanisms of recruitment include the needs assessment and ongoing community engagement efforts (small focus groups); however, COVID-19 has interrupted many of our previous methods of recruiting new members. Because of challenges around how we engage with the community (physical distancing, no groups, etc.), recruitment has largely depended on individual council member referrals for the time being.
