2 DETERMINING THAT THE REQUEST TO REMOVE CONDITION 6 AND THE EXCHANGE OF A TYPE 47
3 LIQUOR LICENSE FOR A TYPE 48 PUBLIC PREMISES LIQUOR LICENSE FOR ANDREW ADELMAN
4 DBA POLLY ESTHER'S, LOCATED AT 181 EDDY STREET, WILL SERVE THE CONVENIENCE OF THE
5 PEOPLE OF THE CITY AND COUNTY OF SAN FRANCISCO, IN ACCORDANCE WITH SECTION 23803 OF
6 THE CALIFORNIA BUSINESS AND PROFESSIONS CODE; WITH CONDITIONS.

8 WHEREAS, Andrew Adelman dba Polly Esther's located at 181 Eddy Street is seeking the removal of
9 Condition 6 and the exchange of a Type 47 liquor license for a Type 48 public premises liquor license; and

10 WHEREAS, The City Planning Department has verified that the area is properly zoned; and,

11 WHEREAS, The Police Department recommends the approval of the removal of condition 6 and the
12 exchange of a Type 47 liquor license for a Type 48 public premises liquor license; however, with the addition of a
13 new condition, now, therefore, be it

14 RESOLVED, That in accordance with Section 23803 of the California Business and Professions Code, the
15 Board of Supervisors of the City and County of San Francisco hereby determines that Condition 6 should be
16 removed and the Type 47 liquor license shall be exchanged for a Type 48 public premises liquor license with the
17 following condition:

18 Condition: Applicant shall make a reasonable attempt to make some type of food available to its patrons,
19 for example, finger foods and/or microwave type food.




