This unique retail concept serves a distinct and unmet community need that no existing licensee on Clement Street or elsewhere in San Francisco currently provides.

The beer and wine offered at Food Folk will reflect this same mission: exclusively small, independent American craft producers. This is categorically different from the beer and wine selections available at existing off-sale licensees in the neighborhood, which carry conventional, mass-market, and internationally sourced products. Food Folk's license would give inner Richmond residents convenient neighborhood access to American craft and small-producer beverages that are not otherwise available in the immediate area.

San Francisco has a strong and growing community of consumers who are committed to supporting domestic small producers and local economies. Food Folk's presence on Clement Street directly serves this community, while also contributing to the broader city goal of supporting independent, mission-driven small businesses.

Alcohol sales will be strictly off-sale — sealed containers for consumption off premises only — presenting minimal nuisance risk to the surrounding residential and commercial community.

The San Francisco Planning Department has confirmed no objection to the issuance of a liquor license at this location. Furthermore, during the required ABC notification period, no protests or objections were filed by any member of the public, neighboring businesses, or community organizations — demonstrating clear community acceptance of Food Folk's presence and business model.

For these reasons, the issuance of a Type 20 license to Food Folk LLC would serve the public convenience and necessity of the neighborhood and the City of San Francisco.

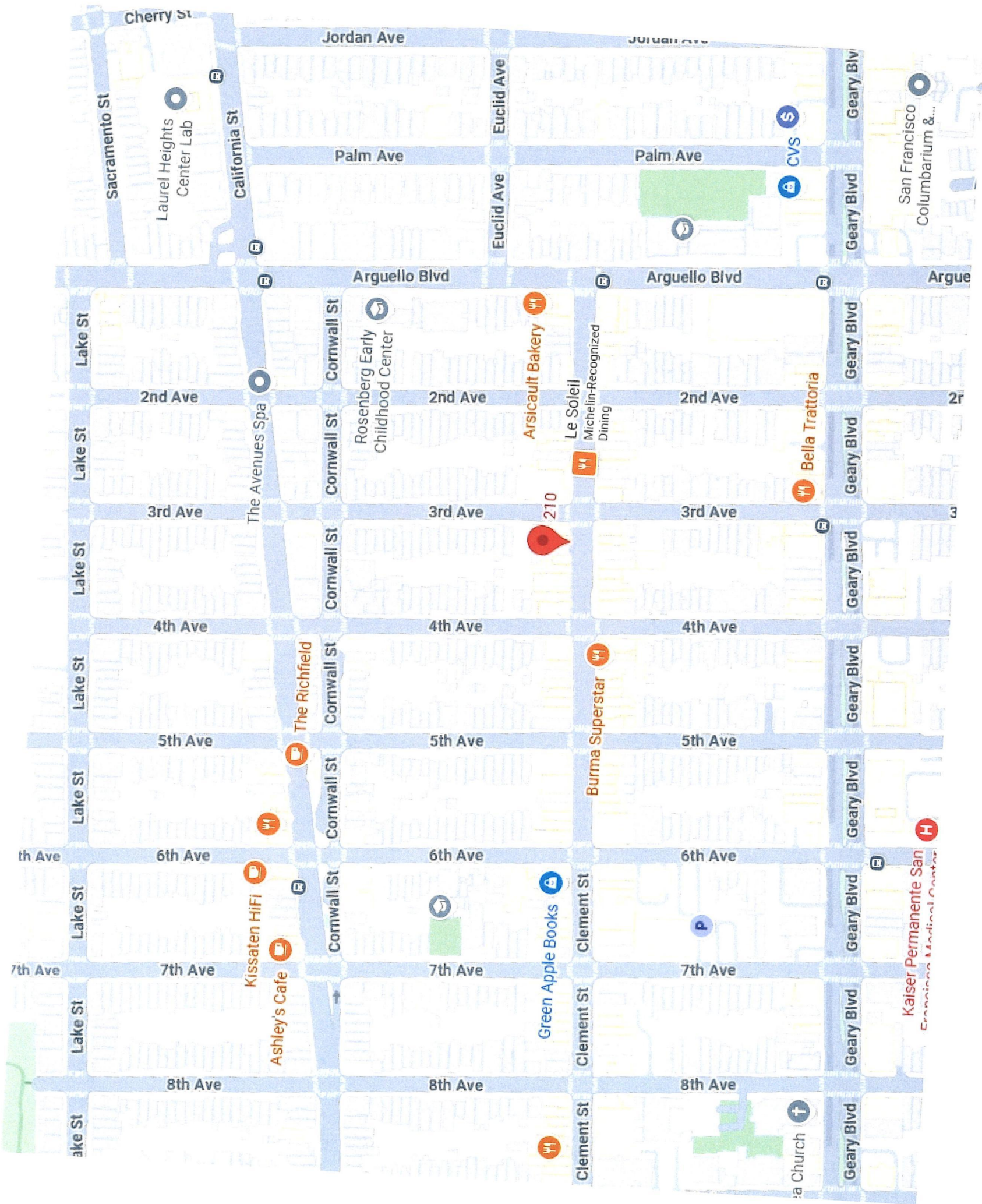

Food Folk is a first-of-its-kind specialty grocery store — the only 100% domestic grocer in the United States. Every product carried by Food Folk is sourced exclusively from small, independent American producers, with a primary focus on California. This unique retail concept serves a distinct and unmet community need that no existing licensee on Clement Street or elsewhere in San Francisco currently provides.

The beer and wine offered at Food Folk will reflect this same mission: exclusively small, independent American craft producers. This is categorically different from the beer and wine selections available at existing off-sale licensees in the neighborhood, which carry conventional, mass-market, and internationally sourced products. Food Folk's license would give inner Richmond residents convenient neighborhood access to American craft and small-producer beverages that are not otherwise available in the immediate area.

San Francisco has a strong and growing community of consumers who are committed to supporting domestic small producers and local economies. Food Folk's presence on Clement Street directly serves this community, while also contributing to the broader city goal of supporting independent, mission-driven small businesses.

Alcohol sales will be strictly off-sale — sealed containers for consumption off premises only — presenting minimal nuisance risk to the surrounding residential and commercial community.

The San Francisco Planning Department has confirmed no objection to the issuance of a liquor license at this location. Furthermore, during the required ABC notification period, no protests or objections were filed by any member of the public, neighboring businesses, or community organizations — demonstrating clear community acceptance of Food Folk's presence and business model.

For these reasons, the issuance of a Type 20 license to Food Folk LLC would serve the public convenience and necessity of the neighborhood and the City of San Francisco.

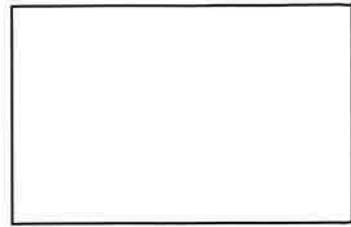
