9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Allied Insurance Company v. the City
12 and County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-15-
13 543789 by the payment of \$60,000. The lawsuit involves alleged property damage arising
14 from flooding.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 January 22, 2015, and the following parties were named in the lawsuit: Plaintiff: Allied
17 Insurance Company; Defendants: City and County of San Francisco and Precision
18 Engineering, Inc.




