

1 [Wherry Housing]

2 SUPPORTING AND URGING THE MAYOR'S OFFICE OF HOUSING TO SUBMIT A
3 PROPOSAL TO THE PRESIDIO TRUST FOR A SUBSTANTIAL PORTION OF WHERRY
4 HOUSING TO BE LEASED BY THE CITY AND COUNTY OF SAN FRANCISCO OR MADE
5 AVAILABLE TO THE CITY AND COUNTY THROUGH EMPLOYMENT PROGRAMS OR OTHER
6 AGREEMENTS THAT WILL PROVIDE HOUSING FOR LOW INCOME SAN FRANCISCANS
7 AND SAN FRANCISCANS AT RISK OF HOMELESSNESS.

8 WHEREAS, San Francisco is facing the most severe shortage of
9 affordable rental housing since World War II; and,

10 WHEREAS, The Board of Supervisors placed a Declaration of Policy
11 on the June, 1998 ballot which asked "Shall the City and County of
12 San Francisco, which has been asked to pay for and provide non-
13 emergency support services to the Presidio, encourage the restoration
14 of the land to natural open space, and act to ensure that the 1,900
15 existing housing units at the Presidio, including Wherry Housing, be
16 preserved at the Presidio, with the majority of that existing housing
17 to be set aside for rental to San Francisco residents of all income
18 levels, including both affordable and market-rate housing?" and this
19 Declaration of Policy was Proposition L on the ballot; and,

20 WHEREAS, Proposition L was passed by 93,002 of San Francisco
21 voters, representing 53.1% of the vote; now, therefore, be it

22 RESOLVED, That the City and County of San Francisco supports and
23 urges the Mayor's Office of Housing to submit a proposal to the
24 Presidio Trust for a substantial portion of Wherry Housing to be
25 leased by the City and County of San Francisco or made available to

1 the City and County through employment or other agreements that will
2 provide housing for low income San Franciscans and San Franciscans at
3 risk of homelessness.




