3 **Resolution authorizing the San Francisco Department of Public Health, AIDS Office**
4 **(DPHAO) to enter retroactively into an agreement with the California Department of**
5 **Health Services Office of AIDS (OA), the primary contractor, and expend funds in the**
6 **amount of \$25,310 for evaluation services; for the period of July 1, 2002 to December**
7 **31, 2002.**

9 WHEREAS, The federal Centers for Disease Control and Prevention (CDC) mandated
10 an evaluation system for local interventions (ELI); and,

11 WHEREAS, Funding for implementation of ELI was not forthcoming from CDC or the
12 State of California; and,

13 WHEREAS, OA recently identified one-time funds for local health jurisdictions to offset
14 the startup costs of ELI system implementation; and,

15 WHEREAS, OA has agreed to reimburse DPHAO in the amount of \$25,310 from these
16 funds; and,

17 WHEREAS, As a condition of receiving the funds OA requires DPHAO to enter into a
18 Contract (The "Agreement"), a copy of which is on file with the Clerk of the Board of
19 Supervisors in File No. 021252, which is hereby declared to be a part of this resolution as
20 if set forth fully herein; and,


21 WHEREAS, The Department proposes to maximize use of available funds on program
22 expenditures by not including indirect costs in the contract budget; now, therefore, be it

23 RESOLVED, That DPHAO is hereby authorized to enter retroactively into a contract
24 agreement in the amount of \$25,310 with OA, the primary contractor, for services under the
25 this agreement; and, be it

1 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
2 indirect costs in the budget of the agreement; and, be it

3 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
4 agreement on behalf of the City.
