4 **Resolution/authorizing the Department of Human Services to accept and expend a**  
5 **grant in the amount of \$1,916,317 from the U.S. Department of Housing and Urban**  
6 **Development for the McKinney Continuum of Care Homeless Assistance Programs.**

8 WHEREAS, Under the Stewart B. McKinney Homeless Assistance Act as amended,  
9 San Francisco is eligible to receive funds under the Supportive Housing Program (SHP) and  
10 the Shelter Plus Care Program (S+C) from the U.S. Department of Housing and Urban  
11 Development; and,

12 WHEREAS, The U.S. Department of Housing and Urban Development has awarded  
13 eleven grants to the City and County of San Francisco, totaling \$1,916,317 to fund programs  
14 to reduce homelessness in San Francisco; and,

15 WHEREAS, The Department of Human Services is the authorized administrator of the  
16 McKinney Continuum of Care Homeless Assistance Programs grant and has prepared an  
17 expenditure schedule for use of the funds for FY 02-03 in the amount of \$1,916,317; and,

18 WHEREAS, The grant budget includes a provision for indirect costs of \$68,394 to be  
19 allocated equally between the Department of Human Services and the contracted agencies,  
20 now, therefore, be it


