13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. Article 4 of the San Francisco Park Code is hereby amended by amending  
15 Section 4.10, to read as follows:

16 (a) No person shall consume alcoholic beverages of any kind in any building, children's  
17 playground, swimming pool, or restroom, or any of the parks or portions of parks as follows  
18 except with permission of the Recreation and Park Department:



6 and enjoyment of the park.




