7 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
8 does hereby appoint the hereinafter designated persons to serve as members of the Graffiti  
9 Advisory Board, pursuant to the provisions of the San Francisco Administrative Code, Section  
10 5.170, for the term specified:

11 Julia Viera, new position, seat 4, must represent a nonprofit organization who provides  
12 services related to the City's beautification and neighborhood cleanup programs, for an  
13 indefinite term;

14 Joseph Porcoro, new position, seat 5, must represent a nonprofit organization who  
15 provides services related to the City's beautification and neighborhood cleanup programs; for  
16 an indefinite term;

17 John Omernik, new position, seat 8, must represent private schools in San Francisco,  
18 for an indefinite term;

19 Stephen Shinn (residency requirement waived), new position, seat 9, must represent  
20 the contracting agency for Municipal Railway Shelters, for an indefinite term;

21 Machaela Hctor (residency requirement waived), new position, seat 10, must be an  
22 at-large member with knowledge in graffiti issues, for an indefinite term;

23 Deborah Mansfield, new position, seat 11, (non-voting member) must represent  
24 neighborhood organizations from varying districts in San Francisco, for an indefinite term;

1 Nino Parker, new position, seat 12, (non-voting member) must represent neighborhood  
2 organizations from varying districts in San Francisco, for an indefinite term;

3 Marc Anthony Bruno, new position, seat 13, (non-voting member) must represent  
4 neighborhood organizations from varying districts in San Francisco, for an indefinite term;  
5 and, be it

6 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 7 1. The membership of the Graffiti Advisory Board has a goal to be representative of  
8 the diversity of the City and County of San Francisco.
- 9 2. Applicants Stephen Shinn and Machaela Hctor, new appointees, who are not  
10 residents of San Francisco, are persons with experience that uniquely qualifies  
11 him/her to serve on the Graffiti Advisory Board.
- 12 3. The Graffiti Advisory Board has attempted to fill the position, for which Stephen  
13 Shinn and Machaela Hctor were nominated, with individuals who are City resident  
14 and who have the specific experience, skills, and qualifications, but has been  
15 unable to do so at this time. The Rules Committee has certified that Stephen Shinn  
16 and Machaela Hctor are qualified to serve on the Graffiti Advisory Board.
- 17 4. After exercising due diligence, the Board of Supervisors concludes that there are no  
18 other possible representatives, who are residents of San Francisco and who have  
19 the specific experience, skills, or qualifications possessed by these applicants, and  
20 who are willing to serve on the Graffiti Advisory Board at this time; and, be it

21 FURTHER RESOLVED, That the Board of Supervisors waives the residency  
22 requirement for Stephen Shinn and Machaela Hctor, as allowed in cases where no qualified  
23 City resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that  
24 requires person(s) appointed to boards, commissions, and advisory bodies established by




