2 **RESOLUTION ACCEPTING AND EXPENDING A SECOND GIFT-IN-PLACE, VALUED AT**
3 **UP TO \$850,000 FROM THE STERN GROVE FESTIVAL ASSOCIATION TO THE**
4 **RECREATION AND PARK DEPARTMENT TO FUND CONSTRUCTION OF**
5 **IMPROVEMENTS TO THE NORTH HILLSIDE AND ENTRY PLAZA AT THE RHODA**
6 **GOLDMAN CONCERT MEADOW.**

8 WHEREAS, The City owns real property located in Sigmund Stern Grove and Pine
9 Lake Park known as "The Concert Meadow"; and

10 WHEREAS, Through a series of community meetings, a conceptual improvement plan
11 was developed by the Recreation and Park Department, the Department of Public Works and
12 the Office of Lawrence Halprin and approved by the Recreation and Parks Commission on
13 November 20, 2003 per the Resolution No. 0312-008; and,

14 WHEREAS, The Stern Grove Festival Association is a non-profit organization
15 committed to offering an admission-free, performing arts series every summer in the Rhoda
16 Goldman Concert Meadow; and,

17 WHEREAS, on May 20, 2004, the Recreation and Park Commission recommended to
18 the Board of Supervisors to accept and expend a first Gift as Resolution No. 0405-004; and
19 on June 8, 2004, the Board of Supervisors passed Resolution No. 356-04 to accept and
20 expend the gift, and,

21 WHEREAS, The Stern Grove Festival Association has completed construction of
22 Concert Meadow facilities renovation as a gift-in-place ("Gift"), valued at up to \$12,000,000, in
23 Sigmund Stern Grove, to the City and County of San Francisco; and,


