3 **Ordinance authorizing settlement of the lawsuit filed by Matthew Gyves against the City**
4 **and County of San Francisco for \$500,000; the lawsuit was filed on November 2, 2023,**
5 **in San Francisco Superior Court, Case No. CGC-23-610147; entitled Matthew Gyves v.**
6 **City and County of San Francisco, et al.; the lawsuit involves alleged personal injury**
7 **arising from an incident on April 3, 2023, in which Mr. Gyves sustained significant**
8 **injuries when he was thrown from his bike after hitting a pothole on 15th Street in San**
9 **Francisco.**

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
13 authorizes the City Attorney to settle the action entitled Matthew Gyves v. City and County of
14 San Francisco, et al., San Francisco Superior Court, Case No. CGC-23-610147 by the
15 payment of \$500,000. The lawsuit involves alleged personal injuries that Mr. Gyves claimed
16 to have sustained arising from an incident on April 3, 2023 in which Mr. Gyves was thrown
17 from his bike after hitting a pothole on 15th Street in San Francisco.

18 Section 2. The above-named action was filed in San Francisco Superior Court on
19 November 2, 2023, and the following parties were named in the lawsuit: Plaintiff Matthew
20 Gyves, Defendant City and County of San Francisco.
