2 Street Neighborhood Commercial District (File No. 120814)]

3 **Resolution extending by 45 days the prescribed time within which the Planning**  
4 **Commission may render its decision on a Ordinance (File No. 120814) amending the**  
5 **San Francisco Planning Code by: 1) adding Section 744.1 to establish the Fillmore**  
6 **Street Neighborhood Commercial District along Fillmore Street between Bush and**  
7 **Fulton Streets; 2) amending Section 151.1, a portion of Table 151.1, Section 263.20, and**  
8 **Section 607.1(f) to make conforming and other technical changes; 3) amending Sheets**  
9 **ZN02 and ZN07 of the Zoning Map to rezone specified properties to the Fillmore Street**  
10 **Neighborhood Commercial District; and 4) adopting environmental findings, Planning**  
11 **Code Section 302 findings, and findings of consistency with the General Plan and the**  
12 **Priority Policies of Planning Code Section 101.1.**

14 WHEREAS, On July 31, 2012, Supervisor Olague introduced legislation amending the  
15 San Francisco Planning Code: by: 1) adding Section 744.1 to establish the Fillmore Street  
16 Neighborhood Commercial District along Fillmore Street between Bush and Fulton Streets; 2)  
17 amending Section 151.1, a portion of Table 151.1, Section 263.20, and Section 607.1(f) to  
18 make conforming and other technical changes; 3) amending Sheets ZN02 and ZN07 of the  
19 Zoning Map to rezone specified properties to the Fillmore Street Neighborhood Commercial  
20 District; and 4) adopting environmental findings, Planning Code Section 302 findings, and  
21 findings of consistency with the General Plan and the Priority Policies of Planning Code  
22 Section 101.1. A copy of said legislation is on file with the Clerk of the Board of Supervisors  
23 in File No. 120814 and is incorporated herein by reference; and

1           WHEREAS, On or about August 10, 2012, the Clerk of the Board of Supervisors  
2 referred the proposed ordinance to the Planning Commission, which currently is reviewing the  
3 proposed ordinance; and

4           WHEREAS, On or about October 17, 2012, Supervisor Olague requested that the  
5 Planning Commission continue the proposed Ordinance from the October 25, 2012 Planning  
6 Commission hearing to the November 29, 2012 Commission hearing; and

7           WHEREAS, The Board, in accordance with Planning Code Section 306.4(d) may, by  
8 Resolution, extend the prescribed time within which the Planning Commission is to render its  
9 decision on proposed amendments to the Planning Code that the Board of Supervisors  
10 initiates; and

11           WHEREAS, Supervisor Olague has requested additional time for the Planning  
12 Commission to review the proposed Ordinance; and

13           WHEREAS, The Board deems it appropriate in this instance to grant to the Planning  
14 Commission additional time to review the proposed Ordinance and render its decision; now,  
15 therefore, be it

16           RESOLVED, That by this Resolution, the Board hereby extends the prescribed time  
17 within which the Planning Commission may render its decision on the proposed Ordinance for  
18 approximately 45 additional days, until December 7, 2012.
