1 **URGING THE SAN FRANCISCO DEPARTMENT OF PARKING AND TRAFFIC TO INSTALL**
2 **SPEED BUMPS ON THE 500 BLOCK OF CLIPPER STREET AND OTHER APPROPRIATE**
3 **TRAFFIC CALMING MEASURES TO PROMOTE PEDESTRIAN SAFETY IN THE NOE**
4 **VALLEY NEIGHBORHOOD.**

6 WHEREAS, The south central part of Noe Valley is quiet residential neighborhood of
7 single family homes ;and,

8 WHEREAS, Clipper Street from Dolores to Diamond Heights have been increasingly
9 used by motorist to traverse from the east side to the west side of the city and vica versa; and

10 WHEREAS, Residents along the 500 block of Clipper Street have been increasingly
11 concerned about pedestrian safety because of the constant speeding of vehicles along Clipper
12 Street at all hours of night and day, and

13 WHEREAS, Car accidents along Clipper Street are not uncommon occurrences as well
14 as incidents of parked vehicles being damaged by speeding cars, and

15 WHEREAS, Residents must be extra cautious when backing out of their driveways for
16 fear of being hit a speeding vehicle; and

17 WHEREAS, Crossing Clipper Street can be sometimes hazardous for seniors, children
18 and the physically challenged , and

19 WHEREAS, Neighbors have expressed their desire for the City to take measures to
20 address the issue of pedestrian and traffic safety in the area, especially the installation of
21 speed bumps on the 500 Block of Clipper Street ; now therefore be it

22 **RESOLVED**, That the Board of Supervisors of the City and County of San Francisco
23 urges the Department of Parking and Traffic to install speed bumps on the 500 Block of
24 Clipper Street as well as other appropriate traffic calming measures in order to promote
25 pedestrian safety in the Noe Valley neighborhood.


