ORDINANCE NO. 370-98

1 [Alcoholic Beverages]
2 AMENDING ARTICLE 4 OF THE SAN FRANCISCO PARK CODE, WHICH PROHIBITS
3 DISORDERLY CONDUCT IN CITY PARKS, BY AMENDING SECTION 4.10 TO ADD PARKS
4 AND PORTIONS OF PARKS IN WHICH ALCOHOL CONSUMPTION WILL BE PROHIBITED
5 WITHOUT PERMISSION AND SETTING FORTH STANDARDS FOR OBTAINING
6 PERMISSION.

7 Note: Additions are underlined; deletions are in ((double parentheses)).

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Article 4 of the San Francisco Park Code is hereby amended by amending
10 Section 4.10, to read as follows:

11 (a) No person shall consume alcoholic beverages of any kind in any building, children's
12 playground, swimming pool, ((or)) restroom, or any of the parks or portions of parks as
13 follows, except with permission of the Recreation and Park Department:

14 Argone Park

15 Boeddeker Park

16 Civic Center Plaza

17 Duboce Park

18 Fulton Park

19 The areas of Golden Gate Park consisting of:

20 The Panhandle (bordered by Fell, Baker, Oak and Stanyan Streets)

21 Stanyan Meadow Area (bordered by JFK Drive, Stanyan Street, Waller Street
22 and Kezar Drive)

23 Kezar Stadium Park (bordered by Waller Street, Stanyan Street, Frederick Street,


24 Martin Luther King Junior Drive and Kezar Drive)

25 Hayes Valley Playground




