3 **Resolution declaring April 2024 as National Donate Life Month in the City and County**  
4 **of San Francisco.**

6 WHEREAS, More than 483 individuals in San Francisco are currently on the national  
7 organ transplant waiting list, and 22 patients die each day in the United States waiting for a  
8 donated organ to become available; and

9 WHEREAS, Donor Network West serves as the federally designated Organ  
10 Procurement Organization in Northern/Central California and Northern Nevada that works in  
11 close partnership with families, doctors, nurses, and coroners in hospitals to connect donors  
12 to recipients; and

13 WHEREAS, Donations of organs and tissue are life-giving acts recognized worldwide  
14 as expressions of compassion that save thousands of lives each year; and

15 WHEREAS, The need for donated organs is especially urgent in the Asian, Latino and  
16 African American communities; and

17 WHEREAS, A single individual's donation of the heart, lungs, liver, kidneys, pancreas  
18 and small intestine can save up to eight lives; donation of tissue can save and heal the lives of  
19 up to 75 others; and

20 WHEREAS, The spirit of giving and decision to donate are not restricted by age or  
21 medical condition; and

22 WHEREAS, Over 19 million Californians have signed up with the state-authorized  
23 Donate Life California Registry to ensure their wishes to be organ and tissue donors are  
24 honored; and

1           WHEREAS, California residents can sign up with the Donate Life California Donor  
2 Registry when applying for or renewing their driver’s license or ID cards at the California  
3 Department of Motor Vehicles; now, therefore, be it

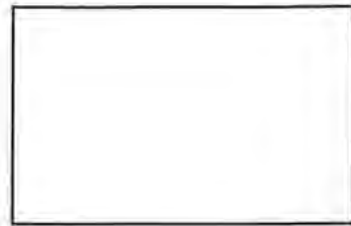
4           RESOLVED, The San Francisco Board of Supervisors hereby declares the month of
